ORDINANCE # I-2018

N ORDINANCE ADOPTING THE CITY CODE OF ORDINANCES.

Be it ordained by the City Council of Richland, Iowa

Section 1. Pursuant to published notice, a public hearing has been duly held and the City Council of Richland, Iowa hereby adopts the Richland Ordinances of 2018 as the 2018 Richland Municipal Code.

Section 2. An official copy of the Municipal Code, as adopted including a certification by the City Clerk as to its adoption and effective date, is on file at the office of the City Clerk.

Section 3. Copies of the code shall be kept available at the City Clerk's office for public inspection and sale at cost.

Section 4. All general ordinances or parts thereof passed prior to January 5, 2018, not contained in the Richland Code of Ordinances are hereby repealed except as hereafter provided, or special ordinances not named.

Saved from repeal:

Section 5. This ordinance shall be in full force and effect upon publication as required by Iowa law.
